1) Meeting Minutes of February 28, 2007 meeting were approved.

## 2) Activities Updates

- a) YMF
  - i) Newsletter Info John said that he will check with Bob Wright on when articles for the summer issue are due. **ACTION: JOHN, FRED**
  - ii) Critical Issues Discussion Chris explained that the event was a success. It was held at the Elephant & Castle Pub in Center City and about 30 people attended. Food was planned for 50 people, but the tight timeframe for finding and announcing the location could have contributed to the low attendance. The Pub was very helpful and Chris recommended using it again next year.
  - iii) Remaining Budget Don handed out a copy of the budget and said that the remaining budget will allow us to have several good events before the year is out. It was decided to pay next year's web fees with this year's money. Suggestions to save money for another good bowling event in the fall was brought up and agreed upon.
  - iv) YMF Board Elections John described the process for the election. If anyone has any questions or a position request, they should contact John.
  - v) Remaining Winter Social Prizes A discussion was held on how to distribute the remaining raffle prizes from the Winter Social. It was decided that everyone who comes to the Election Happy Hour will receive one free raffle ticket and the drawing will be held at the happy hour.
  - vi) College Student Chapter Meetings John explained that there is a meeting set up to take place at Widener on Monday, April 23 at noon. They are requesting Transportation and Structural Engineers to attend and share recent projects. Also, a meeting with Drexel is anticipated in the near future and there were a couple volunteers on the board willing to help out, including Don, Fred, Chris, and Chrzan.
