1) February $16^{\text {th }}$ meeting minutes were approved and are to be posted to the eRoom and website. (Brown/Farley)
2) Section/National Update
a) Section
i. The Section Dinner Meeting will be taking place at the Villanova Conference Center in Radnor, PA. The presentations will be on Remembering Karl Terzaghi: "The father of Geotechnical Engineering," The $11^{\text {th }}$ Street Bridge - Successful Re-sequencing During Construction and Ethics. Drew reminded everyone that this is not at Villanova University.
ii. There were approximately 7 to 9 student scholarship applicants and the Section awarded 2 students scholarships.
iii. The PA Infrastructure Day is on May 11, 2015 and the ASCE is allowing members to meet with legislators in Harrisburg on the $11^{\text {th }}$. Currently, the ASCE is looking for those interested in attending.
iv. There has been a tour scheduled for Dilworth Plaza midday on May 14, 2015.
v. The ASCE Philadelphia Section announced that the Spring Social will be on May 14, 2015 at the Le Meridien on Arch Street; the RSVP for this event is not currently open.
b) National
i. Board members Drew, Kolleen, and Chris R. will be attending the student conference at Penn State University (Main Campus) on Sunday April 12, 2015 to judge the concrete canoe, geowall and steel bridge competitions respectively. Drew mentioned that reimbursement for certain funds used while volunteering for the student conference could be reimbursed. (Sirianni/Backlund/Renfro)
ii. Sometime this year ASCE will be transitioning the eRoom to Higher Logic. An Archive Best Practices webinar took place which Jeremy and Chris R. were able to attend. Jeremy and Chris R. provided a recap of the webinar stating that though there isn't an official release date for Higher Logic, all Younger Member Groups should have the files that are to be transferred to High Logic in a folder labelled "Higher Logic" by July 1, 2015. There was discussion on backing up the YMF's files externally as a second "backup" in case some unforeseen issues come about during the transition. It was mentioned that there is a possibility that those YMGs with very large amounts of files can use Zythos to store larger amounts of data. Nha agreed to assist with this transition.

## 3) Recap of Past Events

a) ASCE YMF Mock Interviews - The Mock Interview sessions ran from February $23^{\text {rd }}$ to the $26^{\text {th }}$ and were very successful; 11 applicants, 10 scheduled interviews and 9 interviews conducted. A survey was sent to each of the participants to gain feedback on the sessions. The Mock Interview Committee also reached out to the volunteer interviewers for their feedback. The committee discussed all of the feedback during a debrief conference call held on April 1, 2015. The committee plans to run the next session in the fall semester.

b) Spring Happy Hour - The Spring Happy Hour at $2^{\text {nd }}$ Story Brewing Company was very successful and there was a lot of positive feedback about the venue and the food. The food was a little pricy and this event went slightly over budget; the chairs suggested that this is accounted for in next year's budget.
c) West Philadelphia Soup Squad - The West Philadelphia Soup Squad community service event went very well; 10 people attended to help make 85 servings of soup. The event lasted approximately 2 hours. There was interest from both parties to do this type of event again.
d) ADS Facility Tour - The ADS tour in New Jersey was a successful facility tour with just under 20 people attending. The event was a tour was of a plastic corrugated pipe manufacturing facility which was followed by a presentation at a bar/restaurant near the facility. Food was provided by the ADS representatives. If this venue were to be used again for presentations it was suggested that an HDMI cord be used to link directly to the monitors already in the room.
e) GETT Expo - Paige and Amanda attended Great Valley High School on March 21, 2015 to participate in their Girls Exploring Tomorrow's Technology (GETT) Expo. Approximately 60 girls participated in their tower building competition. Teams were to build a tower out of paper, masking tape and paper clips. The activity took up a lot of space but the girls seemed to enjoy the activity.
f) ASCE YMF/PSPE Joint Happy Hour - The ASCE YMF and Delaware County PSPE joint event was very successful. There were presentations from Pennoni Associates, Powell Trachtman, Jacobs and Communications Test Designs Inc. and PDHs were distributed. The YMF partly sponsored this event with an $\$ 100$ donation.
g) Mastery Charter Career Day - The Mastery Charter High School career day took place at the Lenfest Campus on $4^{\text {th }}$ Street in Center City. There were about 130 panelists that represented various career types. The students were very enthusiastic and asked very good questions. Scott will do a recap on this event. (Cepietz)
h) Boyertown School Visit - Brett attended the Boyertown School and presented "What is Civil Engineering" to 8 of their classes.
i) Arcola STEAM Day - Brett visited Arcola Intermediate School in Norristown, PA for their Science, Technology, Engineering, Art and Math (STEAM) Day event where he talked about civil engineering to the group.
4) Upcoming Events
a) CANstruction - Build night for CANstuction will be on Friday, April 17, 2015. The team will be building a rocket with its title being, "To Philadbundance and Beyond." With the help of former board member, Steve Maakestad the CANstruction team was able to receive a generous donation of cans from Campbell's. The team will be meeting shortly to discuss progress and ideas on how to construct the rocket on build night. b) West Philadelphia Soup Squad - With such positive feedback from the previous soup squad community service event the community service chairs are planning another event with the West Philadelphia Soup Squad on either April $20^{\text {th }}$ or April $27^{\text {th }}$. c) Upper Darby High School Outreach - Kolleen and Jeremy will be attending Upper Darby High School on April $23^{\text {rd }}$ to present to some of their engineering classes. There are two sessions scheduled: 9:10-10:30 AM and 1:22-2:41 PM. Jeremy mentioned he may not be able to stay for the second session and it was suggested that the YMF membership could be asked for volunteers via email blast.
d) Adopt-A-Highway - First ASCE YMF/ASHE YMC joint Adopt-A-Highway cleanup scheduled for April 25, 2015 (rain or shine). The group will meet at the Fireside Bar \& Grill at 1:00 PM and will commence the cleanup shortly after. The cleanup will take about 2 hours and gloves, safety vests and trash bags will be provided. Participants will be invited to stay for a happy hour at the Fireside Bar \& Grill post cleanup.
e) Critical Issues Seminar - The Critical Issues Seminar (CIS) is tentatively set for May 6, 2015 with the topic being P3 projects. As of now, the professional development chairs are leaning toward using Ladder 15 as the venue for the CIS. As far as speakers, they're looking into having PennDOT's head of P3 projects sit on the panel as well as another PennDOT representative. Darren has also been in contact with one of his colleagues to serve as a potential panelist. Darren is looking to have several different P3 project perspectives on the panel. Chris R. mentioned that he could possibly get a person to represent the contractor's point of view to sit on the panel and Mike Z. stated he could so the same for a lawyer. The chairs mentioned that their next steps are to work on the event logistics. Darren stated that Ladder 15 may have a 75 person minimum to use the space on the $3^{\text {rd }}$ floor but he'll double check to see if they're flexible with that number. Allie added that ASHE agreed to contribute $\$ 200$ to the CIS and MASITE agreed to contribute $\$ 200$ as well. f) Phillies Tailgate - Mike reserved 125 tickets for the Phillies game against the Braves on July 30, 2015 in Section 310, rows 1-7 and part of row 8. Mike mentioned that the Phillies are offering a $\$ 4.00$ per ticket discount to non-profit organizations which resulted in better seats for the same price as last year.
